CCHA Takes Title to the 1905 Four Chimneys Building on the Old Base

At the November 2006
Annual Meeting of the
Clinton County Historical
Association, Board President Roger Harwood signed
documents accepting
transfer of Building 610,
also known as the Four
Chimneys Building, located
on the former Plattsburgh
Air Force Base at 98 Ohio
Avenue.

The three story brick building will provide CCHA with 6,500 square feet of space for exhibitions, offices, and storage of its collection.

CCHA Board members have worked for nearly two years to obtain the site which will serve as a permanent home for the Association's collection and administrative offices. An exhibit developed by the Lake Champlain Maritime Museum of artifacts recovered by the Valcour Bay Research Project will be on loan to the Association and will be placed in the first gallery. CCHA will open at its new location in early spring 2007.

CCHA is very fortunate to receive the Four Chimneys Building in good condition, minimizing the need for major construction projects.

CCHA's Board is grateful to the Board and staff of Plattsburgh Airbase Redevelopment Corporation for their persistent efforts, the results of which will enhance the experiences of Museum visitors for generations.

Phase I of converting the building to a museum finds energy-related projects at the top of the "must do" list. Ken Mousseau of Plattsburgh, has generously donated an electric boiler, which will allow for conversion to electric heat.

Other projects include renovation of the basement, thoroughly cleaning the building, windows, and carpets; making the building handicap accessible, repairs to various restroom facilities, tinting the windows to protect exhibits, and painting the exhibition areas.

Keeping with tradition, the Lighthouse opened on Sunday of Memorial Day weekend. Volunteers staffed the Lighthouse each Sunday from July 2nd through Labor Day Sunday.

Visitors on July 2 included photographer Fred Arce who presented CCHA with a framed print of one his best known photographs: Bluff Point Lighthouse in the winter with snow covered Mt. Mansfield in the background.

Melinda Borshoff, a descendant of Civil War veteran and Plattsburgh Breakwater Light keeper, Mitchell Bully, continues to support CCHA. This fall she donated a small tin pitcher used for "spirits of wine," an alcohol product probably used to clean the lenses on the breakwater lights.

A special summer visitor to the Lighthouse was Allen Messina and his wife. Allen is the great-great grandson of Civil War veteran William Herwerth, and his wife Mary, who were keepers of the Bluff Point Lighthouse. The Messina's were soon to have an addition to their family.

Greg Light of Light's Jewelers, designer of a charm of the Lighthouse, generously supported the Lighthouse this year by donating a 14 karat gold version of the charm. Light also gives a portion of the proceeds from sale of all of the Lighthouse charms to CCHA. Linda Harwood chaired a raffle for the

donated charm that brought over \$1500 to CCHA. Jane Chapman of Plattsburgh was the raffle winner.

The new interpretive sign for the Lighthouse is in draft form and being reviewed by the Lake Champlain Basin Program and New York State DEC. It should be ready for installation for the 2007 season.



Fall 2006 Busy for Area Historians

Municipal historians of Clinton County had a full schedule of meetings this fall. On September 20, 2006, the semiannual workshop of town, village and city historians was convened by County Historian Addie Shields, at the new Battle of Plattsburgh Association auditorium. The meeting included a "sneak preview" tour of CCHA's Four Chimneys Building and a visit to the Sailly Warren House at 3 Cumberland

Avenue.

City Historian and CCHA Board Member James Bailey attended the fall conference of the Association of Public Historians of New York State (APHNYS) in Canandaigua, October 1-2. On October 13, 38 historians from the five counties of northeastern New York, comprising APHNYS Region 6, held their fall workshop at the

Adirondack Museum in Blue Mountain Lake. Issues such as proper certification for municipal historians and the vacancy in the State Historian position, as well as planning for upcoming observations such as the Champlain-Hudson Quadricentennial were among the agenda items at the gatherings.

CCHA Hosts Clinton County Postal History Program

A lively discussion of Clinton County Postal history unfolded Monday evening, December 4, 2006, at the CCHA monthly program.

Glen Estus of Westport, a postal collector, gave a quick overview of terms along with some statistics of post offices in and out of fourteen towns. Estus then shared examples from his collection of covers showing some 50 post offices that once operated in Clinton County.

Several persistent "mysteries" discussed included:

- The location of "Paul's Rock" in the Ellenburg area.
- The possible location of the "East Peru" post office.

Many participants left the presentation eager to go through old boxes of family letters to see if they owned items cancelled at some of the post offices of the past.

Construction Costs in Days Gone By



The bill is undated but we can estimate that the work occurred between 1840 and 1860 and it seems to relate mostly to carpentry work.

Drollette Recognized for Volunteer Effort

Herman Drollette was recognized for donating over one hundred hours in the renovation of the Clinton County Historical Association's Four Chimneys Museum located at 98 Ohio Avenue on the former Plattsburgh Air Force Base.

The presentation of a life membership to the CCHA was made at a meeting of the Adirondack Mountain Club by CCHA Trustee Linda Harwood. "The CCHA Board of Trustees voted to recognize Herman's outstanding contribution at its last meeting. Herman also donated over one hundred hours in the restoration of the Bluff Point Lighthouse. We are fortunate to have his assistance at our new home."



Roger and Linda Harwood, both members of the CCHA Board of Trustees were at the AMC meeting giving a Power Point presentation on the restoration of the Bluff Point Lighthouse. They also gave those attending an update on the progress at the Four Chimneys Museum, reporting "volunteers have invested over seven hundred hours cleaning, painting and making numerous repairs to the building in order to prepare it for our collection."

It was noted that CCHA's Sailly Warren House closed on January 26 in order to allow volunteers to begin the packing process.

Sailly "Excellent Mead" Recipe

From the CCHA Collection comes a recipe for "Excellent Mead," a sweet wine.

Contemporary recipes, according to the American Mead Association, are varied. Two are shown here

Name of Recipe: Vanilla Mead


Recipe Ingredients: 4.5 kg Dark Honey, 300 ml Vanilla essence water to 25 litres, yeast nutrient, all purpose wine yeast

Recipe Process: Mix honey in very hot water to sterilize. Make up to 25L with water and Vanilla. When temp is 30 deg C, add yeast and ferment to dryness. Add clearing agent and bottle. Let sit for at least 12 months for a good taste, better after 2 years.

Name of Recipe: MMMMM Good

Recipe Ingredients: 8 lbs clover honey, 6 Lbs fresh raspberries, 4 oz fresh ginger, 4 cups sugar, citric acid, yeast nutrient, gypsum, Irish moss, bottled water, champagne yeast

Recipe Process: Add honey, moss, acid, nutrient, gypsum, sugar, and ginger to 2 gal water, boil for ten min, remove scum, remove from heat. In a blender, puree berries with water, add to honey-water mixture, mix well. Pour into primary, add water to make 5 or so gal. Start yeast, pitch into primary. Keep warm, 75-80 deg. Two weeks in primary, two weeks in secondary, prime and bottle in champagne bottles. OK after about a month and a half. Better if you wait one year.

Valcour Bay Research Project: Rediscovering a "Moment in Time" to be Inaugural Exhibit at the Four Chimneys Museum

The Lake Champlain Maritime Museum's (LCMM) exhibit of artifacts recovered by the Valcour Bay Research Project will be the inaugural exhibition at the Four Chimneys Museum this spring.

The exhibit will include items recently recovered as well as those recovered in the eight years the project as been active. These items represent a tangible link to Lake Champlain's crucial role in the American Revolution.


LCMM and CCHA collaborated in the recovery of more than 100 Revolutionary War artifacts from Valcour Bay in June 2006. Valcour Bay Research Project volunteers Ed Scollon and Craig Allen spent many hours relocating artifacts that the survey team had found during the previous five years of diving.

The artifacts came from both the east and west sides of the American line. The recovery was undertaken with funding from the Lake Champlain Basin Program, under a permit from the New York State Museum and with oversight from the U.S. Naval Historical Center.

The artifacts were removed to the Conservation Lab at LCMM where they were stabilized and prepared for exhibition. Along with the copious amount of shot and shell that was retrieved, a number of personal items were also uncovered. A pair of sliding temple eyeglasses was recovered and while they are not intact, all the components are present, including both lenses.

In addition to the spectacles, a wellpreserved portion of a small sword was also found. Though very utilitarian in appearance, this type of weapon would have been carried by an American officer. It is hoped that the cleaning and conservation of the sword will reveal markings that may lead to information on its date and place of manufacture.

Perhaps the most exciting items recovered with the Valcour Bay artifacts are three additional pieces of the exploded 6-pound cannon from the gunboat *New York*. Three pieces of this gun were brought to the lab during the initial artifact recovery from the site in 2001. When the new fragments are conserved and reassembled with those already on display, LCMM will have constructed more than 85% of this cannon.
